The overbilling for the Health Insurance Premiums that were previously posted to the software system has been corrected. She stated that the current budget (2021-2022) was closing with \$571,000.00 to the good, which will roll over into next year (2022-2023) which begins Oct 1, 2022.She stated that approximately \$300,000.00 was a result of the water surcharge, but that \$200,000.00 plus was not allocated. Ms. Hourigan stated that the first interest payment was due Oct 15, 2022 for the 2022 Revenue Bond, which was a portion of the funds allocated in the 2022-2023 FY Budget. There would be a principle and interest payment due in April 2023.Mayor Pro-Tem Parker stated reiterated that the books would close today (9/30/22), verified that all checks had been written and stated that it was a good way to start the 2022-2023 Fiscal Year. It was then discussed that the new software would be much more user friendly and that the Council would be able to access the numbers for observation purposes.
