Call the office ONLY if your violations are not listed or if you require further information for disposition of this offense.

FINE SCHEDULE

SPEEDING VIOLATIONS:

Speed violation based on the number of miles over posted speed limit. If alleged speed is 25 miles above posted speed limit, contact Court for fine and court cost.

DRIVING SAFETY COURSE INSTRUCTION / REQUIREMENTS FOR CERTAIN MOVING OR SPEEDING VIOLATIONS
**(excluding those in a construction zone)

Certain moving offenses may be dismissed by requesting to participate in a driving course. If you do not provide written notice to the Court on or before your appearance date of your desire to do so, you will lose that right.

THE REQUIREMENTS TO ATTEND A DRIVING SAFETY COURSE FOR DISPOSITION OF YOUR CITATION ARE:

Make your written request by **CERTIFIED MAIL RETURN RECEIPT REQUESTED** and pay your **court costs ONLY** in the amount of \$144.00 OR \$169.00, for **SPEEDING IN SCHOOL ZONE**, in the form of a **MONEY ORDER** or **CASHIER'S CHECK (NO PERSONAL CHECKS)** payable to **OLNEY MUNICIPAL COURT** or online: <https://www.fastgovpay.com/olney/guest/municipal-court/search> on or before the due date of your citation. Do NOT send the amount listed on the reverse side in addition to the court costs.

1. Provide proof of Liability Insurance and a Copy of valid non CDL Texas driver's license with this request.
2. Not have been speeding 25 miles per hour or more of the posted speed limit or 95 miles per hour or in a construction zone.
3. Have NOT completed or currently taking a driving safety course within the past 12 months (from date of offense) for ticket dismissal.
4. Provide the Court with a copy of your driving record **TYPE 3A** ISSUED BY THE STATE OF TEXAS that you can order online at www.dps.texas.gov. It is your responsibility to furnish the driving record to the Court PRIOR to your deadline for completing the course.
5. If approved, you must inform the instructor that you are taking the course to have a ticket dismissed and to which court this ticket was assigned. Must be taken with a **STATE APPROVED** Driving Safety Course.
6. Sign the following sworn statement BEFORE a Notary Public or in the Judge's office ONLY if you are taking the driving safety course.
7. Be advised that you have 90 days, upon receipt by the Court of your WRITTEN request to complete the driving safety course.

I hereby request to participate in a Driving Safety Course. I enter a plea of No Contest / Guilty and swear I am not currently taking a Driving Safety Course or a motorcycle operator course nor have I completed a Driving Safety Course or a motorcycle training course in the past twelve months that is not shown on my driving record.
